ENTRY GUIDELINES

ELIGIBILITY: Entry is open to all artists 18 years of age or older.

ENTRY FORM INSTRUCTIONS: Entry fees and the form remittance address are specified on the attached Entry Form. Complete and submit the Entry Form by mail, along with your fees and a 4" x 6" photo of each entered item. Please submit no later than May 12, 2017. Entry fees are non-refundable from Mistlin Gallery/CCAA.

CONDITIONS: Work may be for sale but it is not required. Mistlin Gallery will receive a 40% commission on all sales made during or as a result of the show. Artists will be paid their proceeds after the exhibit closes.

RECEIVING: All fiber art entries will be received at Mistlin Gallery on Saturday, June 3, 2017 between 10:00 a.m. and 1:00 p.m. All entries must be hand-delivered and ready for hanging or display. No shipped entries can be accepted.

All quilts will be center hung. Quilts require two hanging sleeves with a separation of 2" in the center. Each quilt must be accompanied by a wooden slat 3/8" thick and 1" shorter than the width of the quilt. At the slat's center point a D-ring style hanger must be attached. For more detailed information on center-hanging a quilt, please refer to the Country Crossroads Quilters website www.countrycrossroadsquilters.com.

Wearables must be displayed on artist-provided mannequins. Framed works must have screw eyes and hanging wire.

Parking for delivery is available in the public parking garage at 11th and K Street. The Gallery will validate parking garage tickets.

PICK UP: All entries must be picked up on Saturday, July 8 between 10:00 a.m. and noon.
