Entry Guidelines

FIBER ART ENTRY CATEGORIES

Wall Quilts, Weaving, Felting, Needlework, Dimensional Textile Art, Wearables

ENTRY INSTRUCTIONS

- 1) Complete attached Entry Form and submit with Entry Fees (see remittance address and details on Entry Form). Fees are non-refundable from Mistlin Gallery/CCAA, unless entry cannot be used in the exhibit due to space limitations.
- 2) A color photograph of each entry must be emailed to: loisandsyd@gmail.com
- 3) Deadline for both submissions above is April 3, 2020

DISPLAY INFORMATION

Wall quilts displayed at Mistlin Gallery are hung from center point, therefore quilt entries are required to have two sleeves with a 2" separation in the center. Each quilt must be accompanied by a wooden slat (**baseboard**) measuring **1/4" - 3/8" thick** and 1-2" shorter than quilt width. Attach a D-ring style hanger at the center point of slat, so that the D-ring itself hangs beyond wood. Also, please write your name and quilt title on each wooden slat. For more quilt sleeve, slat, and D-ring information, or to discuss the presentation of other (non-wall) entries, call Ann at (209) 480-6020.

GALLERY CONDITIONS

Exhibitors are encouraged but not required to set a sale price on each piece entered. Mistlin Gallery will receive a 40% commission on all sales made during the exhibit. Fiber artists will be paid their proceeds after exhibit close date.

Saturday, April 25, 2020, between 10 AM - 12 PM. All entries must be hand delivered to Mistlin Gallery, 1015 J Street, Modesto, and ready to hang or display.
